Family Promise Week: October 18-25



Thanks to you, we have a lot to celebrate!

- We **opened our doors** to homeless children and their families in May 2014
- Our first Day Center/Office, a small 2 bedroom house, was donated and renovated by First United Methodist Church and furnished by volunteers
- In May 2018 we moved into our current location, a gift from HODAC, a larger facility, renovated and furnished with grants, donations, and the hard work of many volunteers
- Families are provided with food, shelter, and social services through a network of 35 area churches, community agencies, service organizations, and local businesses
- We have served 175 children in 71 families
- 90% of guest families complete the program and leave with an income source
- Over 2,400 volunteers provide 12,750+ hours of service each year

We do have a lot to celebrate! Among our greatest thrills is seeing the **smiles of children** when they help their parents put the key in the door of their new home!

Even so, **the homeless challenge continues** to impact approximately 600 children in Houston County. Family Promise has the opportunity to meet the needs of many more families. These needs can only be met through the continued support of our community. This past year we have had several unexpected challenges at the Day Center; the need of a new roof, new HVAC units, extensive pest control (due to our location near eating establishments), and tree removal following storms, to name just a few.




